

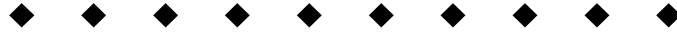

Smart Growth Report

The final report of the Smart Growth Implementation Committee has been completed and is available online to read, <http://volusia.org/growth/smarthgrowth.htm>. Members of the committee are currently scheduling and making presentations of their report to Volusia County municipalities, the school board, and the Charter Review Commission.

Several LWVVC members attended the October 10 presentation to the Charter Review Commission, at which Committee members Clay Henderson, Ormond Beach Mayor Fred Costello, and School Board member Candace Lankford addressed the need to implement the report's recommendations. Representing the 18-member committee, they strongly supported these recommendations as a realistic and viable way for Volusia County to direct and control development, to preserve its green spaces, and to provide a clean and healthy environment for its citizens.

Just two days later, at our October 12 meeting, members of the LWVVC Board of Directors discussed the report and the League's role regarding the recommendations. When it was suggested that board members each take small sections to read and digest, the response was quite positive. Nine board members have agreed to study small sections of the 46-page report, to determine if we have League positions that are supportive of its findings. Furthermore, we would like to involve League members in this discussion. At our November 19th general meeting, we will present our conclusions so that we can all learn and take part in this discussion.

It's also important to note that all the members of the League's local government study committee, that is examining the Volusia County Comprehensive Plan, were at the October 10 Smart Growth presentation. This smart growth initiative certainly has our attention, and we are eager to understand its content and implications.



Charter Review Commission

The Charter Review Commission began its task by holding five "listening sessions" in August and September in different locations in the County in order to learn about citizens' concerns. The commission was then divided into six sub-committees that will each tackle over the coming year an aspect of charter government: (1) Ordinance Review and Management Recommendations; (2) Meeting the Infrastructure of Smart Growth; (3) Intergovernmental Relations; (4) Structure of Government; (5) Integrating Economic Development and Education; and (6) Protecting the Environmental Core. Growth Management will be the preview of the entire Charter Review Commission. More information is available at www.volusia.org.

Once again, as with the Smart Growth report, the League will examine its role in this process. Furthermore, it's important for us to be present and to learn at all of the convened meetings. League members were in attendance at all the listening sessions, and at all of the sub-committee meetings so far. When an email went out to League leaders last month to "**Follow your Charter Review passion for one year,**" we responded by studying the choices, checking our calendars, and choosing the sub-committee we are willing to observe for the next year. Our next step is to involve other members in this task. So, please look closely at the meeting schedule for the Charter Review Commission and the six sub-committees on the opposing page.

The minutes from almost every city council in the County include zoning changes. This is worrisome. Cities throughout the County are struggling with our population explosion as developers are pushing from every direction. Some cities may think of it as a blessing, bringing in new tax bases. But for this writer it spells doom. More people translates to a need for more roads with inevitable congestion. More people portends more needs for schools, police forces, firemen, grocery stores, shopping centers, medical care facilities. Condominiums pave land and block out light and air for single family homes. More people means fewer pristine waterways, less space on the beach, and fewer open spaces. Daytona Beach: Better regulation of rental units has been a hot topic. The ordinance as written requires the registration, licensing, and inspection of all residential rental units. It has created a storm of controversy

because of high fees and because landlords would be required to collect personal information from tenants. As expected, it was rejected unanimously. However, commissioners agreed that there is a need for regulation. Another ordinance, less far-reaching, will be prepared for the next meeting.

Daytona Beach’s participation in Water Authority of Volusia (WAV) is in question. The city is not happy with the interlocal agreement and wrote a letter in April outlining its concerns. However, the concern have not yet been resolved. Commissioners discussed a resolution that would bring these matters to mediation, a necessary step in any litigation or in withdrawing from the organization. LWVVC President Judy Moore spoke against the resolution, emphasizing the importance of WAV as a central water authority and of continuing to build on its efforts. All commissioners voiced support for a central water authority, but the majority think Daytona Beach is not well served by the current agreement. Final vote was 5-2, with McKay and Azama-Edwards dissenting. Thus, the city will begin the mediation process.

The commission also passed (unanimously) a resolution updating its investment policy. Changes will provide more oversight by the commission and city manager, and will require quarterly instead of annual reporting.

**Report: Florida Rights Restoration Coalition
Judy Moore, LWV-Volusia County, LWVF Liaison to the FRRC**

The League of Women Voters of Florida is an active participant in the Florida Rights Restoration Coalition (FRRC), which is composed of over 50 organizations. Whenever a large number of citizens are excluded from the voting process, the League of Women Voters takes notice and becomes involved. We are alarmed that so many Florida citizens, somewhere between 400,000 and 600, 000, cannot vote because of a past felony conviction.

Background

According to the FRCC, Florida is one of four states that strip ex-felons of civil and voting rights after completion of their prison sentence. The practice dates back to the Reconstruction era, when it was instituted as a way to disenfranchise African-American men. Sociologist Christopher Uggen, University of Minnesota, researching for Johnson v. Bush, the federal lawsuit challenging the Florida law, notes that today one in three African-American men is prevented from voting as a result of this policy first placed in the state constitution in 1868. The restriction expands beyond the right to vote. It also includes the right to hold public office, to serve on a jury, and to qualify for licenses required for many jobs.

Ex-felons who want their civil rights restored must complete an application for Restoration of Civil Rights (CRC). Only the Governor and the Cabinet, sitting as the Executive Clemency Board, have the power to restore civil rights to an ex-felon. Because of the huge numbers of ex-felons in Florida who cannot vote, and because of the complicated and arbitrary restoration process, it often takes years before a person's rights are restored.

This archaic and racist practice is also costly. In 2003 Florida allocated \$1 million to hire additional employees to process the growing number of applications. Even more funding was required in 2004. Furthermore, this policy is especially costly and devastating to past felons, limiting their participation in the democratic process and preventing them from holding certain jobs.

FRRC Action Plan

In addition to statewide annual conferences and national retreats, members of the FRRC steering committee strategize monthly via a conference call, organized and moderated by Courtenay Strickland, Director, ACLU Voting Rights Project. The current emphasis is on local meetings with state legislators.

Update on Johnson v. Bush

A representative from the national Brennan Center for Justice often participates in the monthly FRCC onference calls and uses the time to discuss the progress of this case. The 11th Circuit Court has asked the Supreme Court to review the case, which should be done by the end of October.

According to LWV-Florida President, Dianne Wheatley-Giliotti, the LWVF filed an amicus brief on October 14. She notes that the court will have the League brief and the parties' briefs on Monday, October 24, and that it will probably take a couple of weeks before the court considers and rules on the petition.

FRRC Statewide Conference

The FRRC Training Academy is scheduled for Saturday, November 12, 10:00 a.m. to 5:00 p.m. at the New Bethel African Methodist Episcopal Church, 4201 W. Columbia St., Orlando, FL 32811. The academy will feature a series of workshops on legislative lobbying and communications strategies, planning sessions for a 2006 legislative lobbying day in Tallahassee, and effective use of media around specific actions.

Local Study Committee Report—SEPTEMBER-OCTOBER MEETINGS AND BEYOND

We had our first meeting on Sept. 12, 2005, for our 2nd year of study on the Volusia County Comprehensive Plan as it relates to the Government Program passed by the LWVVC in April, 2005.

At the meeting, we had a good, enthusiastic discussion among committee members (Sandy Horikami, Rosemarie Gore, Summer Clayton and Larry Moore) sharing what they have learned and experienced being on city committees and by attending committee meetings. We also had discussion relating to the final report from Smart Growth and the potential changes that might occur if approved in total or in part by the Volusia County Charter Review Commission.

This would have a significant change in the direction this local study committee takes. Committee members hope that whatever happens, the change will provide a better future in our county.

Meanwhile, several members of the LWVVC Local Study Committee are active participants on county-wide and municipal groups all of which will have potential impact on the direction Volusia County takes on the comprehensive plan and our future land use. So, to get further knowledge of the possible impact Smart Growth might have on the Charter Review process, the October meeting of the local study committee was to attend the Smart Growth

Commission presentation to the Charter Review on Oct. 10, 2005, held at Daytona Beach Community College. And, as you must know by now the League of Women Voters of Volusia County was very well represented at this meeting.

SO MUCH HAS HAPPENED; WHAT DOES THIS MEAN -- the LWVVC LOCAL STUDY 2005-06?

The beginnings of our Fall 2005-Spring 2006 Local Study of the Comprehensive Plan (phase 2) may have taken a few turns in order to more fully see the potential changes that the Plan may take in the next year or two - because of the Volusia County's Charter Review - taking place right now; the possible additions to both the charter and the County's Comprehensive Plan because of possible Smart Growth implementation and the CRC sub-committee work that may very well change the substance in wording of the Plan.

Many of the committee are already in key positions to keep the League (and community) updated on the dynamic changes which are occurring.

It has, however - with no bad feelings intended -- truly changed the initial process of completing the second phase of this Study. As Chair I defer to those who are so strongly vested in their respective areas of interest -- whether it is through their government committee work, their work in special interests or their insight from being involved -- and with a long view. Larry Moore and I are attending most of the sub-committee meetings of the Intergovernmental Coordination meeting for the CRC.

It is my hope that by November the Committee will again be able to come together, share some of this insight and try and begin to pull together some of the issues that face us; through our involvement and through the news articles saved and reviewed. It is our hope as citizens in this Volusia County community and as League members that this will more fully educate us before this year's study is over.

Redistricting Petition Report

The Committee for Fair Elections' petition drive is alive and well and right on track. As of mid-October, 475,000 signatures had been collected. As you know, the set of three petitions is a bipartisan and much-needed attempt to change Florida's redistricting process.

And yes, as you are undoubtedly aware, one of the petitions (the one setting up guidelines for districts) was tossed out because its ballot summary contained six words too many. But don't let that deter you! The far-more-important petition is the one establishing a bipartisan commission to draw the lines. It is independent of the others and intact.

We are continuing to take advantage of every opportunity to promote this effort. So far, our league has turned in more than 300 signed petitions! Members have been out in force at such events as a Labor Day union picnic in Daytona Beach, Port Orange Family Days, and a welcome-back fair at DBCC. We have also supplied the guest speaker for several community meetings.
