We have sent letters to DCA in opposition to the marina development on the Wekiva River in DeBary, to the County Council in support of the Commuter Rail Project and to reinstate the funding of the Volusia Soil and Water Conservation District that was removed from the proposed budget for next fiscal year. Rosemarie Gore, our Natural Resources Chair, addressed the Volusia County Council at their regular meeting on August 19, 2007 about LWVVC's concerns of the county adopting the VCOG Map "A" that has been altered from the original county's Smart Growth Implementation Committee Map "A." (Map "A," delineates the conservation areas in Volusia County) Your Board members have been busy trying to keep tabs on and fight for issues that support League positions. I thank all of you who have demonstrated your activism by "acting" on the Action Alerts I've sent out by email.

A New WAV

The Water Conservation Coordinator, Deborah Green, was first on the agenda of the August 15 WAV meeting. Among the water efficiency and education efforts planned is a workshop promoting Green Building and Development of interest to the building industry and the community as a whole. Identified are water-wise programs throughout the state. One of significance is Gov. Crist's executive order stating, by January 1, 2008 "state agencies and departments under direction of the Governor may not contract for meeting and conference space with hotels or conference facilities that have not received the DEP "Green Lodging" certification in water. . ." A workshop is planned for a Florida Green Lodging program in late August at the Palm Plaza Hotel, which currently undergoing recertification as a Florida Green Lodging.

As mandated by the state the St. Johns River Water Management District (SJRWMD) has established Minimum Flows and Levels for Blue Spring and surrounding lakes based on conditions of the year 1995. Now as of June of this year the District has produced a document for implementation of the MFLs, namely: *"Implementation Strategy for Achieving the Minimum Flow Regime for Blue Spring and Other Water Resource Constraints in Volusia County, Florida, (Draft 2007)*

For the August board meeting WAV requested a copy of their model projections versus actual---these are not available. It was also requested that the District send a representative to discuss WAV concerns

regarding the validation of model projections versus actual. Board members are of the opinion it is inadvisable to base water supply needs on these projected figures which lack validation. The board cited other conditions which could affect future flows: 1) with no control on private wells their numbers could increase dramatically; 2) the effectiveness of the water conservation program could be significant. The board agreed they must work closely with the SJRWMD, and TAC should be reactivated to consider the issue of model vs. actual.

A short review of the Flagler County Water Supply Plan Cooperator meeting of July 25 indicated Flagler is shifting from planning to implementation and is looking for partnerships. There is not enough groundwater to meet demands beyond 2011 without increasing harm to wetlands. Flagler County is investigating a number of alternatives, one of which is a ship-based seawater desalination operation

The Water Standard Company also appeared at the WAV meeting to make the same presentation of their innovative ship-based desalination system. The board was very favorably impressed with the features of the system. There are no environmental impacts when the concentrate is discharged, and the need for costly infrastructure is nonexistent. The board will pursue further information on this company.

Two dates were set for League of Women Voters from across continental US to participate in a teleconference discussing the re-establishment of the Observer Corps in our local leagues.

Experience in the group I participated with ranged from up and running to just getting started. We are in the former. Karen McFarland of the League of Women Voter of U.S. conducted the teleconferences. Details of the teleconference were presented to our League Board at their annual retreat in July.

Budget battles are ongoing in every City Council, City Commission and Volusia County Council due to the recent State Legislature attempt to reduce property taxes and bring about more equity in the tax system. It would be wise for as many of you as can to attend budget hearings in your city. Some cities are thoughtfully going about the process; others may cut popular programs to elicit the greatest citizen revolt in the hopes of defeating the amendment. It is a complicated issue and needs careful study by each of us.

Three new observers signed on in the past two months and they are dynamic. Claudia Roth is observing DeLand City Council. We now have two observers for this important commission. Nora Gillespie, a new member, has agreed to observe MPO, Edgewater, and Oak Hill. Whew! I don't know how she is managing all that, but she sends in reports following each meeting. Sandy Horikami's teaching schedule this semester has left her free to observe Lake Helen as well as the awesome task of serving as our local League President. The Observer Corps is active and effective. We do need observers for Deltona, DeBary, Pierson, Volusia County Council and Volusia Council of Governments (VCOG). Can you give a little of your time?

Ormond Beach

On July 3 the audience remarks centered around the requirement that citizens sign a release before anyone can participate in any city activity. This includes a statement that in a way exonerates the City even if they are found negligent. Several parcels of land that belong to the City were recommended for "disposal" however, at least 3 were located on the Peninsula with potential for beach access. It was determined that an assessment be made regarding their value. Another property on Hand close to Clyde Morris has a possible bidder but it lacked an environmental study and may be wetlands that require further study. This too was tabled. The city Police department will be closed at night with a signed agreement between Ormond Beach and the county

Sheriff's office for dispatching /reporting from Ormond Beach.

New Smyrna

(from News Journal articles by Melanie Stawicki Azam)

New Smyrna is trying to insert in their industrial-zoned land a clause prohibiting home improvement stores. These types of stores generate more traffic and remain open longer hours. For economic reasons they want to preserve the industrial land for manufacturing not retail. The Planning Board is fighting 9 Story condos. However the Director of Development Services, Mark Rakowski, is advocating larger footprints for the buildings if this is approved.

Oak Hill (from News Journal articles by Linda Walton)

Citizens can now log on and cite (as well as complain) failed pick-ups in an effort to improve their service.

The city is in dispute with FEMA over the 2004 hurricane clean up fees. They are hoping to resolve the issue before another hurricane hits.

Oak Hill agrees to partner with the county for accurate house counts. Julie Wood, director of the Enterprise Zone Development Agency, has been requesting funds from the city in order to do another census. The latest census has only one area in the northwest quarter of the city eligible for Community Development Block Grant fund usage.

July 23, Passed a resolution to support Map A as presented by the VCOG not the MAP A presented at the citizen's conference held in June and attended by many LWVVC members.

Passed an Ordinance to put several Charter Amendments on the ballot concerning FS101.061 & 166.031.

Some of the budget discussion hinges on the sale of Park Towne acreage and union talks, reduction. Amended land development code to include XIX adult entertainment with all 42 pages of rules and regulations, setbacks .

Edgewater

Negotiated the sale of remaining 82 more or less acres of industrial site entitled Park Towne off Park Ave, to MGM Real Estate, Inc for a purchase price of \$55,000 per acre, \$4.5 million. There were problems within the council about MGM paying half at closing and the city carrying the remaining half interest free for 18 months as well as having a possible 8 acres of wetlands pulled. Instead city manager recommended \$770,000 in road improvements credited to buyer as parcels

developed vote was 3 for sale, one against (Rodgers). Mayor Thomas not present, Rodgers objected to the city carrying the note interest free. Park Towne has been an interest-free purchase by the city for six years. They now have to begin repayment of the debt service set for 15 years. Part of the budget talks hinge on the sale of Park Towne acreage.

The Fire Department has secured two flood prone parcels cleared under the Hazard Mitigation Grant Program. They will now be green space or passive parks.

Villas at the Lakes, amended its land development code with 2007-0-13, to include article XIX adult entertainment with all 42 pages of rules and regulations.

The commissioners approved a charter amendment for the November ballot, providing for exemptions for commercial property to the 35 foot height standard. They also approved two lots in Eastern Shores for a storm water project. *Nora Gillespie*

Lake Helen

The city engineer reported the need to upgrade the water utilities systems by automating the three wells that the city uses for its water supply coordinating the wells so that they can communicate with each other and having a backup generator at one of the stations. This will provide more even output of water from the wells. There is also a need for an emergency generator for one of the three wells. These issues will be investigated further and discussed at subsequent meetings. These upgrades are necessary to comply with the state DEP.

Lake Helen was not a member of WAV because it felt that WAV's interest was not so much on conservation of water but about how the water is distributed throughout the county. Lake Helen felt that water conservation was more important and Vice Mayor Long pointed out that the city has water conservation controls in the city's comprehensive plan, e.g. no golf courses can be developed in Lake Helen.

Lake Helen passed a resolution to adopt Map "A" as environmentally sensitive lands that should be conserved for future generations as recommended by the VCOG Smart Growth Committee.

Lake Helen has minimum size restrictions for new homes built in its historic districts however there are some very small lots that cannot easily accommodate these restrictions. The Commission discussed the possibility of amending the city's comprehensive plan to allow variances on a case by case basis, allowing smaller homes be built and yet maintain the charm of the historic flavor of Lake Helen. The commissioners made a point to emphasize that this would only pertain to already existing small lots.

Citizen complaints about the City Administrator's salary in excess of \$130,000 may have something

to do with the talk of having a Citizen Charter Review workshop set for September 11th. The City Administrator also wears another hat-City Planner-which is one way the Commissioners justify his large salary. *Sandy Horikama*

DeLand City Commission

The first reading of Ordinance Amending Chapter 30 of the Code re Irrigation Meters proposes to eliminate the installation of new irrigation meters. The intent of this ordinance is to encourage residents to conserve water. New construction meters would measure water use and charge water and sewer rates after a set number of gallons/liters used. The St. John's water district has the authority to restrict the city to a set amount of water available for use. However, the St. John's water district has no restrictions on private wells. The second thing is Alex Sink sent a representative to the meeting to explain how the grants have changed under My Safe Florida Home.com. In order to qualify for a grant the house must be homesteaded, built before March 1, 2002, insured for under \$300,000 and located in a wind wind-borne debris region. However, the wind inspections are still free and certificates from the wind inspectors entitle homeowners to a discount from their insurance companies. *Claudia Roth*

Port Orange

July 17 the issue of who pays for what in the clean-up of Rose Bay and the B23 Canal off Rose Bay is still up in the air. The canal was originally built for mosquito control and also called a drainage ditch over the years. Resident Betty Hall has a map from 1926 calling it a boat basin. There is lots of confusion over ownership and history of the B23 Canal. At a Commission meeting in July, Mayor Greene agreed with the citizens that they should not have to pay to dredge the more than 60 years of accumulated silt in B3 canal resulting from the runoff from US 1. He does however agree with the Department of Transportation (DOT) that the homeowners along the canal are responsible for replacing the seawalls if a study of the land surveys indicates that they are not on government property.

Despite major concerns of interested residents, the City of Port Orange has approved a Wal Mart at the corner of Nova and Madeline pending compliance of Wal Mart with a few changes to the design. *Pat Gadbow*

Port Orange (continued)

The State of Florida has permitted the first phase of a Gopher Tortoise relocation bank located on a portion of the City owned well field property. The City will charge developers a fee between \$800 and \$1200 for every tortoise that is moved to the site.

An interchange at I-95 and Pioneer Trail has been

included in the long-range transportation plan for the last 25 years. It will be another 25 years before the interchange will be started. Recently, New Smyrna Beach asked the MPO to remove the interchange from its long-range plan. Port Orange disagrees with removal as the council thinks that traffic on Pioneer Trail will cause the road to fail and that the interchange will help alleviate the problem. Port Orange supports inclusion of the interchange.

Summer Clayton

Daytona Beach

Commissioners approved annexing 126 plus acres in the city east of Clyde Morris, west of Rifle

Range. They also, annexed 10.76 acres at the intersection of US 92 and Tomoka Farms Road. Annexed 5.76 plus acres on W. International Speedway. Approved rezoning 25.33 acres on LPGA for moving Hurst Elementary School. Approved increase in density on N. Beach to increase number of units in a condominium. Approved a zoning map amendment for Seabreeze Lofts. This means less parking spaces on Seabreeze in an already crowded area. Commissioner McKay questioned the starting of the project. They have 5 years to begin the project and a 5 year extension. The Commissioners passed a 9% tax break for next year.
