**About Ann Taylor Moore.....**

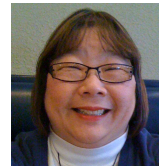

She is also on her second appointment to the *Land Acquisition Advisory Committee for Flagler County*.

In addition, Ms. Moore has an interest in the creative arts and working with people with disabilities, as a co-founder and co-director of *Creative Music Making*. Together with local musicians and teachers, Creative Music Making is a four-day workshop in Daytona Beach with the London Symphony Orchestra. Her work with the disabled extends to her involvement in the *Special Olympics* (1983-1993) and a board member of the *Florida Disabilities Council* (1992-1998).
